### RESOLUTION IMPOSING 2011 PROPERTY TAX LEVY PURSUANT TO MCL 211.24e, 211.34, 211.34d, 211.36, 211.37, and 211.44a, 141.412 AND NOTICE OF CERTIFICATION OF 2011 COUNTY TAX LEVY

WHEREAS, CHIPPEWA County is authorized under the General Property Tax Act, Public Act 206 of 1893, as amended, to levy and collect its allocated and voted property taxes; and

WHEREAS, the General Property Tax Act has been amended by Public Act 357 of 2004, being MCL 211.44a, to require each Michigan County to levy and collect its allocated millage in the summer;

NOW, THEREFORE, BE IT RESOLVED, that pursuant to Public Act 357 of 2004, 6.15 mills, which is the County allocated millage, after application of the "Headlee" millage reduction fraction, shall be levied and collected on July 1, 2011, and,

BE IT FURTHER RESOLVED, that the FIRE/AMBULANCE millage of .4275 mill, the Road millage of .9879 mill, the Recycling Programs millage of .5000 mill, the Jail millage of .6000 mill, and Senior Programs millage of .4994 mill, to which the county is entitled, after application of the "Headlee" and other applicable millage reduction fractions, will be levied and collected on December 1, 2011, and

BE IT FURTHER RESOLVED, that the Treasurer of each city, village and township in CHIPPEWA County is directed to account for and deliver the County tax collections for 2011 in accordance with the provisions of statute pertaining to such collections; and

BE IT FURTHER RESOLVED, that this Resolution, constitutes certification of the levy of the County millages as above described and as set forth on the attached 2011 TAX RATE REQUEST (L4029); and

BE IT FURTHER RESOLVED, that the County Clerk shall deliver a copy of this Resolution by first class mail to the Treasurer of each city, village and township in CHIPPEWA County.

The requirements of MCL 211.24e must be met prior to lovying an operating levy which is larger than the base tax rate but not larger than the rate in column 9.

# NOTICE OF TRUTH IN TAXATION PUBLIC HEARING

PURSUANT TO MCLA 211.44a, CHIPPEWA COUNTY is required to levy its 2011 allocated millage on the July 2011 tax rolls within the County. Prior to establishing any such millage rates, a public hearing must be held, at which the public may offer testimony regarding such proposed levy.

# THEREFORE, PLEASE TAKE NOTICE that the CHIPPEWA COUNTY BOARD OF

COMMISSIONERS will hold a public hearing on its proposed 2011 operating tax millage rates on JUNE 13, 2011 at 6 o'clock PM in the Circuit Courtroom, at 319 Court Street, Sault Ste. Marie, Michigan.

If adopted, the proposed total 2011 operating millage will be 9.1648 mills, as follows:

County Operating,	6.1500 mills,				
County EMS.	.4275 mill,				
County Roads	.9879 mill,				
County Recycling Programs .5000 mill					
County Jail	.6000 mill, and				
County Senior Programs	.4994 mill				

The County Operating millage of 6.15 mills must be levied on the July 2011 tax roll, and all other millages shown above are to be levied on the December 2011 tax roll.

If adopted after the public hearing, the proposed millage will generate operating revenues from ad valorem property taxes by 3.67% over such amounts generated by levies permitted without holding a hearing. This increase accrues from net increases in taxable value due to transfers and mandated rate of inflation, together with certain anticipated revenues from the State of Michigan. Without the hearing, the total maximum operating millage the County could levy would be 8.8401 mills which is .3247 mill below the total millages shown above and would result in a DECREASE of 1.66% below the preceding year's levy.

Chippewa County has complete authority to establish the number of mills to be levied from within its authorized millage rate.
