RESOLUTION NO. 10-12

RESOLUTION IN SUPPORT OF

THE HERITAGE ROUTE

WHEREAS, the Michigan Department of Transportation (MDOT), pursuant to the Heritage Route Act of 1993 (P.A. 69 of 1993), is empowered to designate scenic, recreational, and historic highways in the state, and

WHEREAS, THE PUBLIC HIGHWAY KNOWN AS Michigan State Highway 134 (M-134) extending for Interstate 75 (I-75) to within the County of Chippewa exhibits exceptional recreational quality and passes through an area of significant regional importance, and

WHEREAS, a study has been undertaken by the M-134 Recreational Heritage Route Committee which assesses the quality of and documents the character and features of the Michigan State Highway 134 (M-134) highway corridor, and

WHEREAS, it is intended that the study be forwarded to MDOT in order to nominate Michigan State Highway 134 (M-134) as a heritage route,

NOW, THEREFORE, BE IT RESOLVED that the Chippewa County Board of Commissioners enthusiastically supports the nomination of Michigan State Highway 134 (M-134) as a heritage route and authorizes including this resolution with the nomination documents, and **BE IT FURTHER RESOVLED** that the Chippewa County Board of Commissioners hereby requests and encourages the MDOT to quickly designate Michigan State Highway 134 (M-134) as a heritage route.
